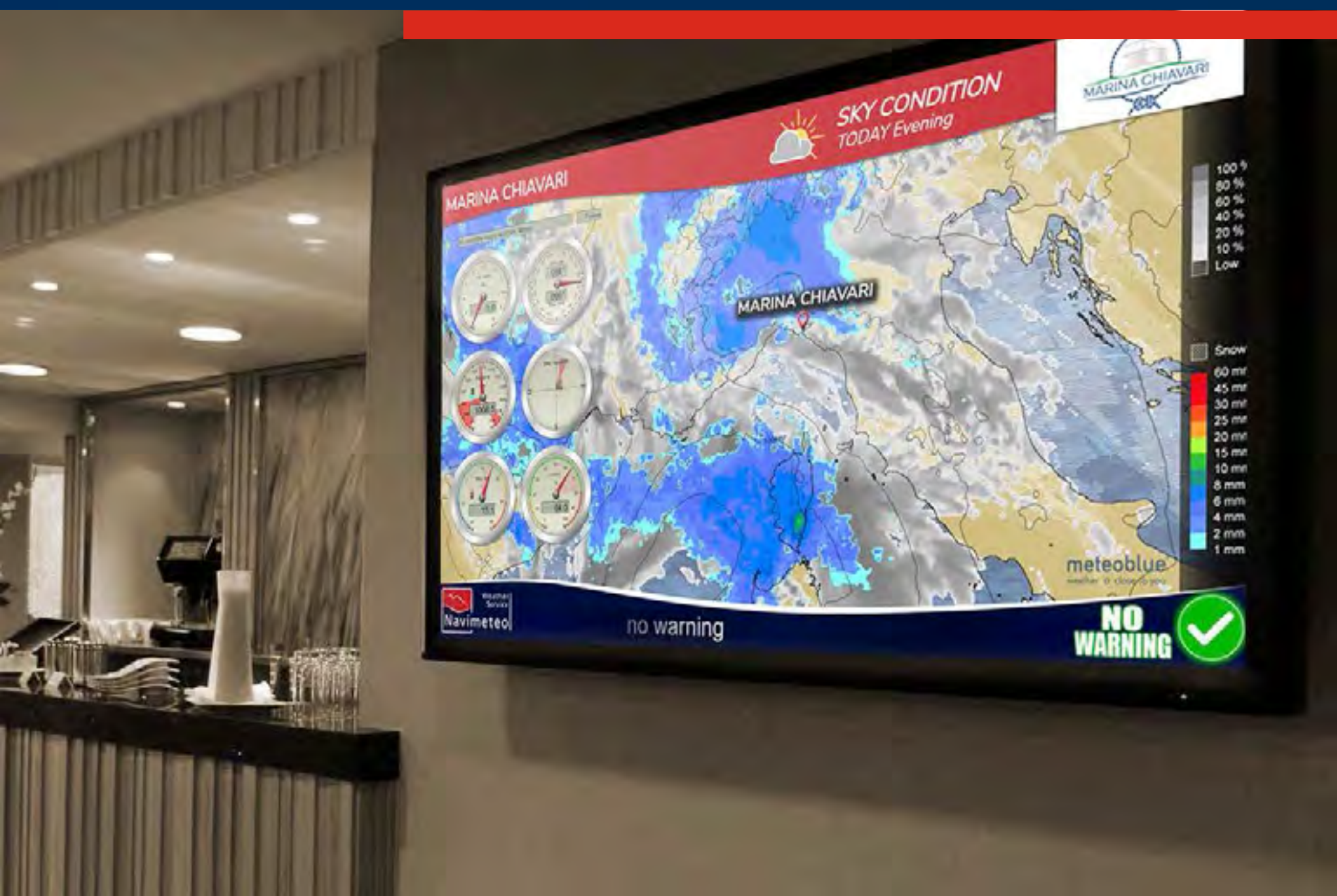
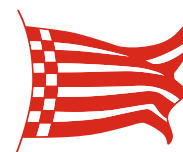

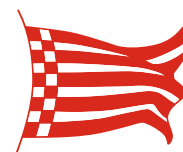
This acquisition marks a significant step in strengthening the Group's digital portfolio and expanding the strategic synergies between technological innovation and maritime expertise.

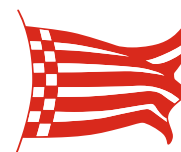
